4. Prices and conditions are based on F.O.B. Plymouth, Massachusetts. All freight is payable at destination, if shipped by road freight, or prepaid and added to the invoice in case of FedEx shipments. SUNCOR will ship by UPS on special request. Sorry no consignee billing.
5. Orders with a minimum value of \$2,500.00 excluding freight, will be shipped **Freight Free** anywhere within the continental USA. Please call for approval, some restrictions apply.
